'Friendly' Competition Benefits Legal Aid

DENVER — A little friendly competition between two frequent adversaries last week benefited Colorado's Legal Aid Foundation.

"We opened our mail to find this great check," said Diana Poole, the executive director of the nonprofit. "Along with it there was a form explaining that it was part of the challenge between the Colorado Trial Lawyers Association and the Colorado Defense Lawvers Association."

The check, which was from the law firm of Jones & Keller, was on behalf of the trial lawyers, who are competing against the defense lawyers in hopes of raising more money and donating more time throughout the month of September. Their efforts came in response to Colorado Supreme Court Chief Justice Michael Bender declaring October professionalism month.

"We were trying to up the ante a bit," said Ross Polkrabek, a shareholder with Jones & Keller, who's chairing the effort for CTLA. Polkrabek's hope was that it might increase pressure on firms on both the CTLA as well as the CDLA sides to give more.

McAllister to serve six years

A former Denver attorney was sentenced to 78 months in federal prison after pleading guilty to financial fraud charges, according to the U.S. Attorney's Office for the District of Kansas, where the case was prosecuted.

Robert McAllister, 62, of Denver, pleaded guilty to two counts of conspiracy to commit financial fraud and one count of bankruptcy fraud.

In his plea, McAllister admitted that from 2006 to 2011 he conspired to obtain wire transfers totaling more than \$1 million
