This year marks the 35th anniversary of the Legal Aid Foundation, and it is indeed something to celebrate. Founded in 1981, our mission was, and still is, to promote equal access to justice by raising funds to provide civil legal aid for low-income Coloradans.

Many things have changed since 1981. Colorado then had multiple federally-funded legal aid programs. Those programs were consolidated in 1999 into a single statewide program, to improve services and to take full advantage of economies of scale. Now, legal aid is frequently provided in ways that were unimaginable in 1981, using technologies such as interactive online form preparation, Skype, and live-chat.

Some things, however, have not changed. ***One constant has been your commitment to equal justice.*** It's reflected in the exceptional leadership and support the Foundation has enjoyed since its inception, and in the consistent and significant growth of our annual campaign. The most important constant though is the incredible difference you've made, and continue to make, in the lives of low income Coloradans. You don't just open the doors to our justice system and level the playing field; you provide pathways out of poverty for individuals and families who are trying to build a better life for themselves.

So – ***Happy Anniversary!*** Over the course of the last 35 years, through your deep and abiding commitment to "justice for all," ***you've changed more lives than you can imagine.***

THE POWER OF COMMITMENT



The Legal Aid Foundation received two generous planned gifts this year. These contributions will likely be used to establish a Special Needs Fund for purposes of supporting and responding to innovations in the delivery of legal services, new or shifting legal needs, unexpected and serious disruptions in other funding, future opportunities to improve or expand service, and similar unexpected needs.

David Butler accomplished his gift through a Charitable Remainder Unitrust, the term of which ended in the spring of 2016. David has long devoted his time, talent and resources to improving access to civil justice in Colorado, and continues as one of our most reliable and generous Leadership Donors. David has served on the Board and as Chair of the Legal Aid Foundation, the Colorado Lawyer Trust Account Foundation (COLTAF), and the Colorado Center on Law & Policy. He was an active member of the Statewide Planning Group to improve the delivery of civil legal aid across Colorado, which led to the creation of our consolidated statewide program, Colorado Legal Services, and he was the Founding Chair of Colorado's Access to Justice Commission.

Bruce Sattler served on the Board of Colorado Legal Services and one of its predecessors, the Legal Aid Society of Metropolitan Denver, for more than 35 years, and was a longtime donor to the Legal Aid Foundation. He helped found the Colorado Lawyer's Committee, and was deeply involved in the American Civil Liberties Union, both in Colorado and nationally. Bruce died in December of 2015, and is remembered not only for his commitment to equal justice, but also as one of the foremost advocates for civil rights in Colorado. The Legal Aid Foundation was one of the named beneficiaries of an Individual Retirement Account in Bruce's estate.

COLORADO LEGAL SERVICES

Your contributions to the Legal Aid Foundation support the work of Colorado Legal Services, the only agency in the state that provides free civil legal aid to indigent clients in every Colorado county. CLS provides necessary legal assistance to Coloradans in the greatest economic and social need.

In 2015, services were provided in **13,411 legal matters** to low-income Coloradans. CLS also stretched its limited resources with technology, *pro se* materials, self help programs, clinics, and *pro bono* programs to serve many more.



Colorado Legal Services (CLS) operates **14 offices** throughout Colorado providing free civil legal services to those who would not otherwise have access to the justice system.


Technology Has Made Legal Aid:

Smarter. Online self-help materials and interactive forms make legal information accessible to everyone.


Faster. Meetings can be held with rural clients using webcam technology, preserving valuable resources and staff time to meet additional legal needs.




Demographics of Clients Served by Colorado Legal Services




2015-2016 REVENUE
